This **MEMORANDUM OF AGREEMENT** is made on 15 February 2020.

Fakultas Ekonomi, Universitas Negeri Semarang (hereinafter called FE UNNES), represented by Drs. Heri Yanto, MBA., Ph.D, in his capacity as Dean, hereinafter referred as **FIRST PARTY**.

Fakultas Ekonomi, Universitas Negeri Jakarta (hereinafter called FE UNJ), represented by Dr. Ari Saptono, S.E., M.Pd, in his capacity as Dean, hereinafter referred as **SECOND PARTY**

ARTICLE 1

SCOPE OF WORK

Both Parties have agreed to conduct a **joint publication** in scopus-indexed journals and/or proceeding based on cooperation among faculty members of FE UNNES and FE UNJ.

ARTICLE 2

RESPONSIBILITIES

The First Party Responsibilities - shall cover the following provisions:

1. Inform and/or select lecturers to write articles ready to submit
2. Organize lecturers to write one lecture's name from The Second Party as the co-author
3. Each author shall submit the manuscript to Scopus-Index journals and/or proceeding

The Second Party Responsibilities - shall cover the following provisions:

1. Inform and/or select lecturers to write camera-ready articles ready to submit
2. Organize lecturers to write one lecture's name from The First Party as the co-author
3. Each author shall submit the manuscript to Scopus-Index journals and/or proceeding

ARTICLE 3
DURATION OF AGREEMENT

This joint publication collaboration will commence immediately started from today-the first submission day to selected journals, to the day of the publication. Each author from both parties is bound by a timeline for publication of his/her own submitted article until the articles are officially published.

ARTICLE 4
AGREEMENT OF PAYMENT

Ali publication cost is each author's responsibility from both parties.

ARTICLE 5
DISPUTE RESOLUTION

The First Party and The Second Party shall base their contractual relationship on the fundamental principles of goodwill and good faith. If there is any differing viewpoints and interpretations of this agreement shall be settled by mutual consultation or negotiation.

ARTICLE 6
MISCELLANEOUS

1. The agreement shall bind and inure to the benefit of the parties, their respective successors and permitted assigns.
2. In the event of any conflict between this agreement and any exhibits hereto, the terms of this agreement shall govern. This agreement may only be ended in writing signed by both of parties that explicitly states that it is intended to amend this agreement.

Any notice or request given or made by one Party to the other under this MoA shall be writing in English language. For purpose of implementing this agreement, the contact persons will be:


